# Notes to accompany the Treasurer's Financial Report: 11 February 2009

Beverley Grigo reported further as follows:

# (1) Financial Reports to 30 June, 2008

The reports prepared by the club accountants for filing to the tax department have not been accepted as there were a number of anomalies in the accounts. The club treasurer has arranged to meet with the accountants to discuss several items that needed to be explained. The club has submitted comprehensive reports to the accountants and it is the treatment by the accountants, or lack of recording, of those items that is of concern.

One item in particular was the fact that the club had deposited funds amounting to \$7,737.31 with BT Financial Group on 19 September 2005 which has never been reported in the financial returns prepared by the accountants in spite of having been given that information for the past four years. The value of the investment as at 31 December was \$6,328.14 which is a loss to date of \$1,409.17.

There is also a substantial amount showing as income which they could not explain on the phone. These matters will be examined and reported on. In the interim period, the account submitted by the accountants is being withheld until the Treasurer is satisfied that the accounts are correct.

(2) Kalbarri House – 3 Mallard Street, Kalbarri.

In the books of the club, the value of the property is stated as being \$35,000.00.

The current estimated sale value provided by Ray White Kalbarri is \$260,000.00.

The valuation is based on a recent sale in Mallard Street plus the fact that the Shire has rezoned the land to R30 which means it is now a 2 unit lot and consequently the land value has risen.

A search of the Title Deeds for the property shows that there is a mortgage on the property held by the National Australia Bank. It appears that the original documents relating to the mortgage are no longer held by any member of the club and consequently a search of the mortgage document is being carried out.

According to the original members of the club, who were involved in the purchase of the property, the mortgage was paid out some time ago. The treasurer is currently conducting a search of the title particulars of the mortgage and will then follow up with NAB why they are still holding a mortgage on the property and also if they are holding the title deeds. The treasurer will report back to the club the results of their discussions with the Bank.

Competition Rules – 2009/2010 Year
NOTICE OF MOTION
Competition Rule No 2.3.2

(A rule defining numbers and types of fish to be weighed in at a field day.)

# 2.3.2 Numbers of Fish and Field Day Bag Limit

A bag limit of a maximum of thirty (30) fish shall be weighed in at any Field Day (including Long Weekends) for competition purposes. Only one (1) wrasse may be weighed-in.

Any competitor presenting more than 30 fish at a weigh-in will have 30 fish chosen by the Field Day Officer weighed in and will be subject to a ten point penalty

Delete the following sentences.

A maximum of one day's bag limit of a particular species as specified by Department of Fisheries WA Regulations can be weighed in for the Field Day.

# Replace with the following

A maximum of two day's bag limit of the "High Risk Species" only may be weighed in for the Field Day where the numbers and species of fish strictly comply with Dept of Fisheries, WA – Recreational Fishing Guide – Finfish Published December 2008. (Medium Risk and Low Risk species types and one day bag limits remain for Field Day weigh-in. Protected species shall not be weighed in.

Members may capture any number of fish within Department of Fisheries WA Regulations for their personal use.

(Only this rule changes – all others remain as is)

# **DISCUSSION ONLY**

#### Reason

Dept Fisheries Category of High Risk" has a maximum total of four (4) only. The range of species across this category is large and conceivable if an angler had a good field day for the two days fishing the angler could have a bag of quality fish that is within the Dept Fisheries rules — but not have the ability to weigh-in and demonstrate his skill/prowess/luck at the Club event. -

I believe all competitors enjoy seeing quality fish being bought to the weigh in table. Probability of this happening often for say total of 8 is low, but more readily achievable for 5 or 6 hence merit of such an achievement should be considered.

# Advantages

- 1 As above
- 2 Requires that an angler sharpens his fishing skills to target more and or different species if he has caught the one-day limit in the first day of fishing.
- 3 A broader competitive element of fishing within the club.

# Disadvantages

- 1 Depends on honesty of angler to weigh in fish he caught each day not the two days limit caught in one day.
- 2 Even though within Dept Fisheries regulations, use of this two day rule for the High Risk species, rather than one, may be seen by some as being greedy, noting that even if rule is not initiated if the angler met with this success he would probably have these species in his bag
- 3 Increases slightly risks in understanding or misunderstanding of rule complexities

# Cervantés to Sandy Point Field Day Report -14 & 15 February

Because of a couple of broken fan belts on the Land Cruiser, we were a bit late for the sign on at the Hill River car park, as the FDO this is not a good look! So starting from Black Rock [AKA "second reef"] Greg and John Rose were signed on and given their Length Comp Tally forms. Making our way northwards from there Peet, Sandra and Lea were located about half a kilometre south of the car park, after pleasantries and paperwork George and Dave were found setting up just north of the car park. Melvin was next a few hundred metres south of the Hill River mouth. John Crompton, Malcolm, Vix and Peter Osborne were right at the mouth of the river and at the completion of formalities, and because of the strong SW to SE winds, we headed back to Black Rock to set up camp in the lee of the limestone and start fishing. As Greg and John had re-located at the river mouth we had the place to ourselves.



The tide was falling and the northerly current contained little weed. Even though we fished all afternoon and into the evening we had no fish bagged. At the grey pre-dawn light Sunday morning I put out the burley pot, rigged a couple of rods for gardies and got the maggots out of the esky. Within half an hour the telltale gardie fins were seen slicing the surface in the burley oil slick. For the next 3 hours the fishing frenzy was on, double headers of gardies, herring and skippy. Even soft-plastics were successful on all the three species! Unfortunately Lea arrived at the end of the burley feast so missed out on the best of it. We broke camp and headed to the car park for the weigh-in.

Of the 14 members that signed on 11 weighed in 8 species, Best Scale Fish went to John Crompton for his 0.620kg tailor, Mal and Vix had fished up at Jurien amongst lots of weed but despite this Mal managed to get the Best Mixed Bag at 5.540kg. Melvin won the Best Shark, a10.300kg hammerhead. Peter Osborne's effort earned him the Best Mixed Bag including Shark at 8.193kg. Well done to all the winners. In the Length Comp 12 handed in their tally sheets that had 23 species totalling up to 68.05 metres of fish and Peet Wessel's winning12.24metres is a great effort. John Crompton caught a 1.575kg tailor before the sign-on so that is now entered in the open competition. This has been a great venue that produces a huge variety of fish, even though the wind was up the seas and swell were docile due to the outer reefs, which makes fishing a pleasure.





Our next FD is the March long weekend at Bluff Creek, which is always very social and very productive in the fishing department.

# **THE TRIP 2009**

# **Updating and Limited Maintenance of the Surfcasters Club Website**

I have offered to update and do limited maintenance of the Surfcasters Club website.

Further details and explanations were provided to the Committee and questions were answered at the January Committee meeting. These details are available to any member if required.

Many things have changed about the Internet, websites and computers in the seven plus years since I started the Club website in 2001. But the basics and essentials of a successful web site have not changed (and will not). These are **Content, Operation** and **Presentation**.

# 1. Target audience and Club's objectives for the website.

What does the Club want from the website? What message is to be conveyed? Who are the target audience? Is there more than 1 different target group? What content are <u>they</u> looking for? What format should it be presented in? These (and more) are critical questions for the Committee and Club to answer.

# 2. Website traffic – deliberate decisions or just luck?

What attracts visitors to a website? Where do they get referred from? What were they looking for? What pages do they start on? What other pages do they look at while they are there? How long do they spend on each page?, etc, etc, Previously these were unanswerable questions.

Usage information is essential before starting any major changes to the website, or before doing any major deletes from the website just because someone might think "it's time to clean it up". This is now possible with intelligent "counters" attached to the web pages.

# 3. Maintaining or Managing a website?

There is a very big difference between merely "maintaining" a web site by adding occasional content to a web site, and proactively "managing" a website for maximum benefit to the club. I believe the Committee and Club <u>MUST</u> give me the ongoing guidance and direction and content needed to achieve the Club's objectives for the website.

# 4. Once off major "tidy up" of the website.

I am prepared to do a once off major "tidy up" for one time payment of \$750. This will remove wrong content, add counters, make all the pages look and operate consistently and check the operation and display, but will **NOT** change many fundamentals of the website.

# 5. Ongoing additions to and maintenance of the website

I am prepared to add the Reel Talk, occasional photos with descriptive captions, add other text, image or content as supplied in electronic format by others, monitor and save copies of counter, tracker, usage and search information for possible future analysis and use. At 3 month intervals, I will provide electronic copies on CD of all the versions of the web pages, counter and usage information to Secretary SCAC. I will do these ongoing additions, maintenance and record keeping for the Club using my own equipment **at no charge initially,** but any extra cash expenses directly involved with this work will be billed to the club. I will review this after the first two months of operation.

# 6. Not currently offered.

I do not offer to do revision, update or removal of any significant quantity of content of the existing information, to regular proactively update ALL relevant web pages with current information from club activities, proactively generate and add new content which other people might find interesting, might be found in search engines and might lead people to the club web site, update or change the presentation of the information, the look, layout, colours, features, coding or organisation of the web site and web pages, for example, to aim at a different or extra target audience. If required, these may be considered separately as extras.

# Recfishwest Report for Surfcasters General Meeting 11 February 2009

One thing that becomes very obvious to me in preparing these reports is that some good things take time to get done. So I won't repeat some things I've said before, but you can be sure those things are moving along and there's some real progress thanks to the new Fisheries Minister and CEO of Dept of Fisheries.

# 1. Review of management arrangements for the West Coast demersal species

Mr Peter Neville is an independent expert appointed by the Minister to review the management arrangements for recreational fishing for demersal finfish in the West Coast Bioregion. Dept of Fisheries ran a workshop recently.

He has a contract to produce a report for the Minister. He was very open about many things, but asked us all to use our judgement on what to report and how to report it. It was the first day of a three-month exercise. Early steps are to get and exchange information and opinions and/or reactions.

The other part, the review of the research, has not started yet and is being done by Michael O'Neill. Some outcome from that would have helped in talking about the management options, but that wasn't possible. Some comments were made about the research but it was not the topic for the workshop, so there weren't any decisions.

There were not many surprises (to me anyway) on most of the points raised by the people there, although there were some different slants. There were some very valid and constructive stuff on the management options and the social and economic impacts. The day gave an opportunity for a lot of points of difference to be explained to everyone as a group, and other facts added and discussed.

Nothing has got any easier. There are still no easy fix options, and there was no significant new information presented which might make the decisions any easier.

# 2. Getting Dept of Fisheries "ahead of the game" on species very important to

Members may have seen the article in the West Australian "Fears for 'bread and butter' fish stocks."

Recfishwest, WA's main recreational fishing body has called for urgent research into stocks of "bread and butter" fish such as herring and King George whiting, saying it fears populations could collapse in just a few years if they are not managed. The organisation had seen stocks of popular catches decline.

"Skippy, herring and whiting are the lifeblood of the near-shore recreational boat fishery," he said. "We are concerned about the domino effect. We don't want to have to manage the dhufish and snapper and then put extra pressure on the King George whiting so that they collapse and then people start fishing for herring, tailor and skippy and they collapse. "We want the Fisheries Department to get in front of the game and look at some of the species that are potentially next in line and develop management strategies."

You may also have noticed the lukewarm response from the Research Director of the Dept of Fisheries. "Fisheries research director Rick Fletcher said it was unlikely fishing regulations would prompt a major shift to other species and ... there was no evidence of a change. However, the department was aware of declining stocks of some species and had applied for Federal Government funding for more research on stocks of herring, tailor and some species of whiting.

Does any of that stuff from Fisheries ring any bells? "No problems." "Unlikely to", (but they don't really know for sure) "We've asked someone else for the money to do the job we are supposed to do, so if/when we don't get the money we'll have someone else to blame when it goes wrong."

"No evidence of any change" "Our stock status is reported each year." Trouble is the "State of the Fisheries" report is so out of date it's laughable. The latest information published is only up to 30 June 2006. That's two years seven months out of date.

What's the latest????? <u>THAT'S</u> what RFW is asking about. Getting ahead of the game means <u>NOT</u> like Cockburn Sound crabs, with Fisheries saying: "there's no problem" "there's no problem" "oh hell, there's a serious problem, close the fishery".

It's enough for me to report that some high level people are very unimpressed with that response and are doing something about it.

# 3. Maximum Size Limit for Whaler Sharks

A new version of the "South Coast Recreational Fishing Guide, Jan 2009" is out. This version has taken out the diagram "Whaler sharks under threat...." panel and shark diagram. But the Category 1 list still says "Whalers over 700mm interdorsal fin length are protected." At the time that version was printed, there was no size limit on whaler sharks.

Since the General Meeting, the WA Government Gazette dated 13 February 2009 has amended the Regulations to include a maximum size limit on ALL whaler sharks for recreational fishermen, but commercial fishermen are still allowed to take whalers of any size.

The current (December 2008) version of the West Coast Fishing Guide doesn't list this whaler maximum size limit, so that is now wrong. The method of measuring the size is shown in the old copies of these brochures

This and other problems have been enough to show that getting these brochures proofread outside the Department MUST and WILL be done.

# 4. Research report on "Maximising Survival of Released Undersized West Coast Reef Fish"

Recfishwest has received an "in confidence" copy of the final draft of the above Fisheries Research and Development Corporation funded research project 2000/194 being written up by Dept of Fisheries. This report is a critical input into the management decisions for West Coast demersal fish, but it is 4 years overdue. One measure of the difficulties RFW has with the contents and the presentation of the report is that it has sent back 12 pages of comments.

# 5. Young Future Leaders Round 2

Recfishwest has applied for funding for a second round of the outstanding and extremely successful Young Future Leaders program.

# 6. Recfishwest Membership

Recfishwest is the peak body representing the interests of recreational fishers in Western Australia. Last year when the organization was under threat, recreational fishers supported Recfishwest, but we need you to continue that support.

Decisions to be made in 2009 will affect future fishing opportunities for your children and grandchildren. Recfishwest intends meeting these challenges and assures you that we will be the most effective vehicle for getting your views heard in this crucial year.

Recfishwest is **your** public voice whenever decisions which affect our fisheries, or access to them, are being made. We want you to become a member of Recfishwest or to renew your membership. Membership costs only \$20 a year per person, \$40 for families and \$10 for seniors.
